The District Educational Officers in the state are informed that in continuation of the State-level training program conducted in July 2025 for 128 ATL District Resource Persons, now proposed to conduct a District Level 3-Day Training Program for all **ATL HMs & In charge teachers** with the collaboration with UNICEF & Vigyan Ashram in the state. These trainings to be planned in between **19.11.25 to 28.11.25** without fail. All ATL HMs & Principals with attend on the day one and all in charge teachers of Atal Tinkering Labs have to attend all the three days to the said training program at their respective District Head Quarters as per the schedule communicated by the District Educational Officers.

All the District Educational Officers in the state are requested to nominate the District Science Officers (DSO) as training incharge to conduct the trainings who can plan and coordinate the training requirements on day to day basis. The DSOs shall follow the instructions of the District Educational Officers / Additional Project Coordinators of the districts and update the progress and take suggestions and support from them to conduct the training without any issues.

The objective of the District Level Training is to.

- Strengthen HMs of ATLs to ensure effective utilization of the lab and access to all the students.
- Build the capacity of ATL In charges for mentoring students on tinkering and innovation activities.
- Integrate ATL activities with classroom curricula.
- Promote collaboration among ATL schools, mentors, Higher Education Institutions.

**Venue & Facilities required for the training:**

- Every district shall arrange the following for conducting a three day workshop are;

- A seminar / training hall for the inauguration, technical sessions and valedictory as per the participants. Round tables for hands-on activities with electrical connections IFP/LCD projector, Laptop / Desktop, microphone and speakers
- Reliable Wi-Fi and essential equipment for smooth conduct of sessions
