





2. Candidates shall purchase the applications at the rate of Rs. 10/- (Rupees ten only) each by paying cash from the District Police offices and Hyderabad Police Commissionerate where he/she intends to apply between 10.30 A.M. to 5.00 P.M. from 10-01-2004 to 28-01-2004 including on Holidays. Applications obtained from any other source or xerox copies will not be accepted at the time of registration.

3. Any candidate appearing after 1700 hrs on 28-01-2004 will not be admitted for scrutiny of applications. Candidates with incomplete applications or applications without prescribed enclosures shall not be entertained.

A candidate should submit only one application form even if he opts for more than one category of posts e.g., if a candidate is applying for all i.e., Police Constable of Civil, AR and APSP and shall mention his preferences at Col. No. 6 of the Application Form.

The recruitment is being made as per provisions of the AP Police Stipendiary Cadet Trainee Rules issued by the Government of Andhra Pradesh in G.O. Ms. No 315, dated 13-10-1999 of Home (Pol. C.) Department. The selected candidates will be appointed to the regular posts only on completion of training and other formalities.

The requisite educational qualifications, age etc., procedure for submitting application, method of selection and other relevant details are given below.

The candidates may read these details carefully in their own interest as any applicant reporting for registration in disregard to any of the prescribed qualifications, lacking in or suppressing any information required to be furnished or furnishing false information and not in the prescribed application pro-forma and without prescribed enclosures, will not be entertained for preliminary screening test i.e., 5 kms. run.

4. The rule of Special representation is applicable. The number of vacancies indicated is only provisional and subject to variation.

5. As per G.O.Ms.No. 109, Social Welfare (V) Department, Dated: 17-06-1988, 75% vacancies of Police Constables in the Police Department in the Scheduled Areas of the State of Andhra Pradesh shall be filled in by the local members of the Scheduled Tribes.

6. In respect of Scheduled Castes, the caste certificate should be issued by the competent authority mentioning the caste and sub-group. As per the orders of the Supreme Court in I.A. No. 1 in C.A. No. 6758/2000 and batch relating to A.P. Scheduled Caste (Rationalisation of Reservation) Act 20/2000, any selection or appointment that may be made pursuant to the impugned Act 20/2000 shall be, subject to the result of Appeals pending before the Supreme Court.

7. Physically Handicapped persons are not eligible.

8. Scale of pay:- P C (Civil, AR & APSP) - Rs.2, 990 -- 5,810/-

9. User Charges: Each applicant must pay Rs. 25/- (Rupees twenty five only) in the shape of cash at the time of submission of application form. Demand Drafts, Cheques, IPOs etc. are not acceptable.

SC/ST candidates appearing for the above selections are exempted from payment of user charges. For this purpose, relevant community certificate shall be enclosed.

10. Age:- The candidates must possess minimum and maximum age 18-22 years as on 1-7-2003. The upper age limit will be relaxable in the following cases:

Sl. No	Category of candidates	Relaxation of age permissible
1	BC, SC & ST	5 years
2	A.P. State Government Employees (Employees of APSEB, APSRTC, Corporations, Municipalities, Local bodies etc. are not entitled for age relaxation)	Length of regular service limited to 5 years

NOTE:- Candidate must produce Secondary School Certificate or equivalent certificate as proof of age and for all categories of applicants the date of reference for computation of age, length of service as Government Employee and educational qualification etc. is 01-07-2003.

11. Qualifications:

I. Educational Qualification: Must have passed SSC or equivalent examination recognized by the State Government as on 01-07-2003.

II. Physical standards:

Male candidates:

- (a). Must not be less than 167.6 cms. in height
- (b). Must not be less than 86.3 cms round the chest on full inspiration with a minimum expansion of 5 cms.

In case of women candidates:

- (a). Must not be less than 152.5 cms in height
- (b). Must not be less than 45.5 kgs in weight.

NOTE : Provided that in case of candidates belonging to STs and aboriginal tribes in the agency areas of Adilabad, East Godavari, Khammam, Mahaboobnagar, Srikakulam, Warangal, West Godavari, Visakhapatnam and Vizianagaram districts where the reserved quota could not be fully utilised for want of sufficient candidates, possessing the requisite physical standards, the physical standards shall be as specified below :

For male candidates:

- a) must not be less than 160 cms. in height.
- b) must not be less than 80 cms round the chest on full inspiration with a minimum expansion of 3 cms.

For women candidates:

- a) must not be less than 150 cms. in height.
- b) must not be less than 44 kgs. in weight.

12. Procedure of Selection:

i) SCT P.Cs (Civil) (Men & Women):

- (a). (i) Male candidates will have to undergo a preliminary selection test of 5 kms run which they must complete in 25 minutes.
- (ii) The male candidates qualified in preliminary selection test in 5 k.m. run and possessing minimum physical standards will be required to qualify in the following 3 items of P. E.T in respect of P.Cs. Civil (Men only) :-

Sl.No.	Item	Qualifying Time / Distance
1.	100 metres run	15 seconds
2.	High jump	1.20 metres
3.	800 metres run	170 seconds

(iii) The 'women' candidates must qualify in the following 3 items of PET as shown against each:-

Sl No.	Item	Qualifying Time / Distance
1.	100 metres run	18.5 seconds
2.	Long jump	2.50 metres
3.	Shot put (4 kgs)	3.75 metres

(b) Candidates possessing requisite qualification, age and physical standards and qualified in preliminary selection test and P. E. T. will be required to appear for written examination to be held on 14-03-2004. The written examination will be of objective type, carrying maximum marks of 100 consisting of questions /items to test general knowledge of SSC standard/aptitude of the candidates, to be answered in one of the four languages viz Telugu, English, Urdu & Hindi. Candidates have to answer the questions on an OMR answer sheet using HB pencils only. For this purpose Candidates should bring HB pencils along with them.

Total of marks obtained in written test (maximum 100 marks), PET (maximum 75 marks) and for height (maximum 25 marks) would determine their order of merit for final selection in each group and community of the district /unit concerned.

(c) The final selection will be strictly on relative merit of the candidates in each category, as obtained by them based on their score in written examination, PET and height.

ii) SCT P.Cs (AR &APSP): -

For the selection of P.Cs (AR &APSP) the candidates declared qualified in the preliminary selection test of 5 K.Ms, must qualify in all the items of PET of I Star standard carrying maximum 125 marks and the minimum qualifying time / distance as detailed below.

1.	100 mts run	15 seconds
2.	Long jump	3.80 mtrs.
3.	Shot put (7.26 Kgs)	5.60 mtrs.
4.	High jump	1.20 mtrs.

A merit list will be prepared on the basis of the total of marks obtained in physical efficiency test of I Star standard (maximum 125 marks) and for height (maximum 25 marks) which would determine their order of merit for final selection in each group and community.

13. The selection of the candidates will be provisional and subject to verification of the original certificates, antecedents, and medical examination. The appointing authority will issue the final selection orders.

14. The Board will not entertain any correspondence from any candidate

15. Stipend and Allowance:

During the period of institutional training (regular as well as extended) candidates selected as Stipendiary Cadet PCs shall be eligible for stipend as fixed by the Government from time to time. On successful completion of training, they will be appointed in the regular time scale of pay as mentioned under para 8 above.

16. Check List

1. Check your eligibility carefully.
2. a) Check whether you have filled in all the columns of the application form correctly and no column has been left blank.
b) Particular care should be taken to ensure that the preference for Civil Police/ AR/APSP is clearly given in item 6 of the application form (for men only).
3. Please ensure that copies of the following certificates/documents are enclosed:
 - a) Proof of date of birth
 - b) Educational qualification
 - c) Community certificate
 - d) Ex-Servicemen certificate / Certificate for children of serving or retired Police personnel / Home Guards Service certificate / Meritorious Sports personnel certificate etc., wherever applicable.
 - e) Study certificate issued by School authorities or Residence certificate issued by M.R.O.
 - f) Certificate from the competent authority in respect of State Government employees, claiming age concession.

Residence certificate will not be accepted, if a candidate has studied in any educational institution upto SSC or equivalent examination, such candidates have to produce study certificates invariably. The candidates, who acquired Degree from Open Universities without studying SSC/Matriculation or equivalent in educational institutions, have to submit residence certificate only (Annexure-I (B))
