Sub: DSH – SADAREM – Release of new SADAREM slots in the state through new service provider for the 1st Quarter – Reg.

Ref: 1. Re-verification process of existing SADAREM certificates taken up by the Government.  
2. Engagement of new service provider **Entro Labs Pvt. Ltd.** w.e.f. 01.01.2026.

I am to inform that regular SADAREM slots in the State were released up to 31.12.2025. Thereafter, due to the ongoing re-verification process of existing SADAREM certificates, new regular slots got hampered, resulting in an increased number of Persons with Disabilities (PwDs) awaiting assessment.

The Government have engaged M/s. Entro Labs Pvt. Ltd. as the new service provider with effect from 01.01.2026 for operation of the SADAREM software and related services. The new platform has been configured in accordance with the provisions of the Rights of Persons with Disabilities Act, incorporating all 21 notified disabilities for issuance of disability certificates.

All the 21 disabilities as notified by the Government of India have been verified, tested, and validated by the DME doctors, and the system is ready for rollout for assessment.

In view of the above, and to address the pending demand for disability assessment, it is proposed to release regular SADAREM slots from March, 2026 for the 21 disabilities at respective hospitals (List of hospitals enclosed) across the State through the new software platform.

Therefore, I request you to, issue necessary instructions to the service provider M/s.Entro Labs Pvt. Ltd., to operationalize and SADAREM slots booking to be made available at Sachivalayams on every Monday and Tuesday at respective hospitals with specified counts for each specialty for the 1st Quarter i.e from March, 2026 to May, 2026 as per the list enclosed with this letter.

This may be treated as **Most Urgent**, considering the accumulation of pending applications awaiting assessment.
